Dear Family,

Year 11 Parent Consultation Evening

I am writing to invite you to a remote video Parents' Evening, which will be distributed across 3rd and 4th February 2021, between 4.30p.m and 7.30p.m to discuss your child's progress with the staff who teach them. Because of the ongoing lockdown, we have decided to offer both nights, for maximum flexibility for both staff and families. Your child may wish to accompany you to these remote appointments.

We are aware that many of you will have questions, worries and concerns around this year that are particularly important, because of the changes to GCSE Assessment procedures. **Because these queries will range across subjects, we have arranged a video by our Senior Team, to be released via Edulink and our social media channels.** We will provide an opportunity to have a Question and Answer session with Mr Scrivens as part of the SLT Achievement Team throughout both evenings to discuss broader matters of attainment or any wider issues, which arise during the evening. Parents can book this appointment in the same way as they do for subject teachers. This means you can spend maximum time talking to subject staff about the details of subject improvement.

The school uses an online booking system for Parents' Evening appointments and it is via this system that you will also be able to access your remote appointments. The booking system can be accessed via a link on the school website or by using this web address: https://www.edulinkone.com/#!/login from Sunday, 24 January at 5pm and will close on Monday 1 February at 5pm.

Several members of teaching staff teach multiple groups across Year 11 and so it may not be possible for them to speak to the parents/carers of every student they teach over the course of the two evenings. If you are not able to make an appointment with a specific teacher, please contact the Academy and we will arrange for the subject teacher to contact you.

We have included a video guide with this letter to assist you in booking your appointments and information on accessing the video appointments on the evening itself. The system creates time based video links, it is therefore very important that you are available at the times that appointments have been made, the appointments will not be able to be extended on the evening should you arrive late and at the end of the timeslot the video link with the member of staff will simply stop.
