End of Term Letter December 2021

It has been another unusual Autumn term with COVID-19 continuing to impact on peoples' lives. We as a school have done everything to ensure a degree of continuity with learning and progress of our students. We appreciate the support that our families have given us during the term. As we come to the end of the autumn term at Thorns we would like to bring your attention to a few matters.

Inclement Weather

If very bad weather and road conditions make it advisable to close the Academy, we will send a text message or email via the Edulink app to all parents to notify a closure. We will also post this decision on the Academy website and social media. The Academy will endeavour to have announcements made by 7.00am. A letter to explain our processes has recently been sent out via Edulink to all families.

If there is no definite announcement about the school by 7.00am, it can be assumed that there has not been a closure and school is open as usual.

Parking on Stockwell Avenue

We would like to thank all parents and carers who collect and drop off students at the Academy and have been mindful of how they park. We continue to encourage all parents and carers to not block the driveways of residents on Stockwell Avenue or Acres Road. We also ask that you park away from the Academy entrance to allow the students to leave the Academy safely and that you try not to block the pavements so that pedestrians can walk safely with pushchairs and younger children.

Uniform expectations

On our return in January, we look forward to greeting our students back to the Academy in full Academy uniform. We hope that you will use the Christmas break to rectify any uniform issues and this particularly means appropriate footwear. Black leather or leather look like shoes are our preferred choice. Can I please take this opportunity to remind families that any type of hoodie is not to be worn as part of our uniform. In addition, multiple studs and nose rings are not allowed nor are extreme haircuts (bright, unnatural colours or patterns) or false nail extensions.
